DoD SBIR Phase I Proposal Preparation Manual

- The goal of the Phase I grant ( \$150K - \$225K over 6 - 12 mos) is to get Phase II funding (\$1M – \$1.5M over 2-3 yrs)
- Writing successful grants takes 150 – 450 hours
- SBIR funding never covers the entire project cost, especially in Phase II! Cash Flow
- 6 months from submission to earliest funding date (more typically 9 -
