Aquinas believes civil disobedience is unacceptable as it prevents the “unity in law and the common good” (p. 1822); he argues that disobedience in itself is unjust. The common good is disturbed when the rejection of a tyrannical government begins to cause division amongst citizens; while some citizens would want the ruling power to remain, others want to dethrone the tyrant (p. 1821-1822).

Aquinas on Justifying Civil Disobedience

Because civil disobedience will provoke tensions, sometimes violent ones, the first three stages must be completed to justify the fourth.

### On Justifying Civil Disobedience

Concerning directness, some argue that civil disobedience is more justifiable the more direct it is since direct disobedience targets the specific legal wrong that prompted it (Greenawalt 1987, 235). While directness may ensure that the objective of the dissent is understood, it has disadvantages; and in some contexts direct action cannot be justified.

Civil disobedience requires the outright and explicit breaking of law, breaching the contract we made with the government when we voted them into power. Law-abiding demonstrations and protests fall under the same category as lobbying, which is decidedly not civil disobedience.
